Dear NAAFA,

Sometimes circumstances are placed in front of us so we can see the parallels. Most of America knows about NPR Journalist Juan Williams being fired (by NPR Senior Vice President for News Ellen Weiss) for comments he made on Fox News show, The O'Reilly Factor. **I would like to suggest that all agents join the agent association....NAAFA. I never thought I would be saying that, but I am. I can see now that I made a big mistake in not joining years ago. I understand they can really help you if you get fired. Who else is there that can help? Most responsible companies have programs to help laid-off employees and workers find other jobs or get retrained. Many companies are cordial and empathetic when they have to tell you to leave. But not here. They abruptly shut your computers off and say "Sue us if you want to know why you were fired!" Yes, this is a sick place to work. And yes, I'm afraid to sign my name. But this is how I see it.**
